Student Parking Agreement (2008-2009)

This agreement will allow the student (hereafter called the permit holder) permission to park a vehicle (hereafter called the permitted vehicle) in an assigned space registered with Gwinnett Soccer Association (GSA) at 925 Cole Drive, Lilburn, GA. 30047 during the school year, Monday through Friday between 6:30 AM and 4:00 PM. The permit holder agrees to the following conditions:

1. Entering and exiting must be done in an orderly and counterclockwise direction (enter near crosswalk) at a speed of 5 mph or less. Park only in your assigned space.
2. No loitering before, during, or after school hours.
3. No smoking, tobacco products, alcoholic beverages, controlled substances (drugs), objectionable materials, loud radios, littering or misconduct allowed on GSA property. Place trash in the provided receptacles.
4. The permit/sticker must be clearly visible and permanently affix to the bottom left (driver's side) corner inside rear windshield of the permitted vehicle. Should a substitute vehicle be used, it must be a permit holder's immediate family member's vehicle and listed in the GSA parking database. A copy of the insurance card for the substitute vehicle must be on file with GSA for the vehicle to be valid.
5. Cole Drive pedestrian crossing is permitted only at the county designated high school crosswalk.
6. Vehicles stickers, temporary permits or parking agreements are non-transferable (no selling, sharing or giving away).
7. The permit holder and/or parents or legal guardians of the permit holder shall release, indemnify, and hold harmless GSA, its officers and/or representatives against any and all liabilities, bodily injury, claims, costs, damages, losses, personal injuries or property damages resulting from the use of the GSA parking facility.
8. Permit holder shall have a valid driver's license and keep in force during the term of this agreement adequate Automobile Liability Insurance with a company approved to do business in the State of Georgia on any permitted or substitute vehicle.
9. Any passengers in permitted or substitute vehicles are subject to all conditions of this agreement.
10. Any violation of this Agreement may result in **VEHICLE BEING TOWED AT THE OWNER'S EXPENSE**. GSA reserves the right to revoke parking privileges for any reason.
